Asia-Pacific Sponsorship Policy & Application

A. SPCRS ASIA-PACIFIC ATTENDEE SPONSORSHIP

The Singapore Prevention & Cardiac Rehabilitation Symposium (SPCRS) Asia-Pacific Attendee Sponsorship is awarded biennially to deserving nurses, physicians, medical scientists, allied healthcare practitioners or educators, and who, in their professional endeavours, are regularly involved in some aspects of cardiovascular rehabilitation in Cambodia, Myanmar, the Philippines and Thailand. The sponsorship seeks to encourage international meeting attendance at the SPCRS for the purpose of fostering bonds between the Singapore Heart Foundation and these aforementioned members of international cardiac rehabilitation societies and programme staff from around the world.

This sponsorship provides each recipient with **complimentary symposium registration**, **as well as free accommodation (two nights) and meals (inclusive of two breakfasts and one welcome dinner)**. The SPCRS Organising Committee will select no more than 12 recipients for this sponsorship. The application deadline for this sponsorship is **12 Sep 2025**. Sponsorship applications will be reviewed by the SPCRS 2025 Organising Committee. Successful applicants will be notified via email upon selection.

B. CRITERIA

- The Asia-Pacific Attendee Sponsorship Application is open to all cardiac rehabilitation professionals from Cambodia, Myanmar, the Philippines and Thailand.
- Applicants must submit an abstract for the SPCRS.
- All applications must be submitted in English.
- Applicants must provide written proof of their employment in the field of cardiac rehabilitation or primary prevention field, supported by a letter from their supervisor printed on the organisation's official letterhead.

C. APPLICATION STEPS

- Complete the Sponsorship Application Form.
- Provide a narrative in English on the benefits of attending the SPCRS (a maximum of 200 words).
- Provide a <u>separate</u> narrative in English on their contributions to cardiac rehabilitation and/or primary prevention in their country of practice (a maximum of 200 words),
- Provide written proof of your employment in the area of cardiac rehabilitation field and furnish a supervisor's recommendation letter printed on the organisation's letterhead.
- Submit a résumé or Curriculum Vitae.

- 2. Provide a <u>separate</u> narrative, in English, on the applicant's contributions to cardiac rehabilitation and/or primary prevention in the country of practice. (a maximum of 200 words)
- 3. Complete the Sponsorship Application Form.
- 4. Provide written proof of employment in the Cardiac Rehabilitation field. Please furnish a supervisor's letter printed on the organisation's letterhead.
- 5. Submit a résumé or Curriculum Vitae in PDF format.

ELIGIBILITY

- 1. Applicants must submit an abstract for the symposium.
- 2. Applications for the SPCRS Asia-Pacific Attendee Sponsorship is open to all cardiac rehabilitation professionals from Cambodia, Myanmar, the Philippines and Thailand.
- 3. Only 12 applicants will be selected by the SPCRS Organising Committee and be awarded the sponsorship.
